1" RAW WATER IRRIGATION TAP FEE IS \$300 IF INSTALLED WHILE LINE IS LAID; AFTER LINE IS ALREADY IN PLACE, TAP FEE IS \$600. PAYMENT MAY BE MADE IN FULL AT TIME OF INSTALLATION, WITHIN SIX (6) MONTHS, OR WITHIN TWELVE (12) MONTHS. TAP FEE MUST BE PAID IN FULL NO LATER THAN TWELVE (12) MONTHS AFTER APPLICATION IS APPROVED.

THE RATE SCHEDULE FOR USAGE IS \$90 FOR THE SEASON. THE ANNUAL USAGE FEE MAY BE PAID IN A LUMP SUM, OR DURING THE IRRIGATION SEASON (APRIL-OCTOBER), \$15 A MONTH FOR SIX (6) MONTHS. USAGE RATE MAY BE CHANGED AT ANY TIME.

THE TOWN OF NUCLA HAS ADOPTED THE FOLLOWING POLICY WHICH OUTLINES THE SERVICES THAT THE TOWN WILL PROVIDE IN THE INSTALLATION OF A RAW WATER TAP AND THE CONDITIONS UNDER WHICH FEES WILL BE CHARGED:

WHEN A RAW WATER TAP IS PURCHASED FROM THE TOWN, THE TOWN WILL FURNISH THE LABOR AND MATERIALS NEEDED TO TAP THE RAW MAIN.

THE TAP WILL BE PLACED WITHIN FIVE FEET OF THE PROPERTY LINE.

NO ONE EXCEPT THE TOWN OF NUCLA MAY TAP INTO THE RAW WATER LINE.

A 1" TAP IS INTENDED TO SERVICE ONE PROPERTY, REGARDLESS OF SIZE OF PROPERTY

THE TOWN WILL NOT ALLOW RAW WATER TO BE PIPED TO OTHER PROPERTY.

PROPERTY OWNERS TAPPING INTO THE TOWN OF NUCLA RAW WATER IRRIGATION SYSTEM UNDERSTAND THIS WATER IS TO USED FOR IRRIGATION ONLY AND SHOULD BE MARKED AS SUCH.

THE TOWN OF NUCLA WILL NOT BE HELD LIABLE FOR PERSONS DRINKING THE RAW WATER.

WASTE WATER FROM THE RAW WATER SYSTEM SHOULD BE USED JUDICIOUSLY SO NO WASTE WATER LEAVES PERSONAL PROPERTY.

THE TOWN OF NUCLA SHALL HAVE THE RIGHT AT ANY TIME WITHOUT NOTICE TO SHUT OFF THE WATER IN THE TOWN RAW WATER SYSTEM FOR THE PURPOSE OF MAKING REPAIRS, CONNECTIONS, EXTENSIONS, OR FOR OTHER USEFUL NECESSARY PURPOSES, INLCUDING THE RIGHT TO SHUT OFF WATER FOR A BREACH OR VIOLATION.

NO RAW WATER USER OR PROPERTY OWNER SHALL BE ENTITLED TO ANY DAMAGES OR TO HAVE ANY PORTION OF PAYMENT REFUNDED FOR ANY INTERRUPTION OF RAW WATER SUPPLY.
